## 5. ENTRY AND ADMINISTRATION (IWWF WATERSKI RULE 14:12)

#### 14.12: Entry and Administration

Each Federation shall declare, through EMS, not later than 60 days before the scheduled start of the first event of the Championships:

- The names of the members of its team
- The names of the competitors entered as "Individuals"
- The names of the competitors entered as Wild Cards
- The names of the Official reserves.

For each competitor registered, the events that they will compete in together with the ramp height for Jump need to be entered.

An entry is considered complete when the Skier's name is registered in EMS and the full Entry Fee Payment has been received.

All payments need to be made by Credit Card/PayPal through EMS. For the Official Reserves, no payment is due at this time.

Any skier entered as a Wild Card or Individual is also to be considered to be a TEAM reserve.

An entered skier may be replaced by a different one without penalty, provided that they have already been entered as a Reserve skier, wild card or individual.

## a) Fines for Late Registration.

Any Federation not meeting the registration deadlines will not be allowed to compete until their Federation pays a fine to the IWWF Representative at the Championships. The fines are as follows:

- \* **US\$50** per skier if the registration is made between 59 and 45 days before the scheduled start of the first event of the Championships
- \* **US\$75** per skier if the registration is made between 44 to 30 days before the scheduled start of the first event of the Championships
- \* **US\$100** per skier if the registration is made between 29 to 15 days before the scheduled start of the first event of the Championships
- \* **Double the Entry Fee** per skier if the registration is made between 14 days until 12:00 (competition local time), 2 days before the scheduled start of the first event of the Championships Example: scheduled start of the first event of the Championships is July 31 deadline to register skier is noon 12:00 UTC of July 29.


Two days before the start of the first event the entry lists shall be closed at noon 12:00 (competition local time) and thereafter the order of competitors entered and paid will be finalised and posted.

The Scorer in consultation with the Chief Judge should post Preliminary Running Orders 7 days preceding the start of events with the orders clearly marked as "Preliminary and subject to change". No change in this order is allowed after noon (competition local time) of the two days preceding the start of events except that a team representative may without penalty:

- 1) Withdraw a skier from the competition.
- 2) Replace an injured skier with a qualified official reserve from the same team with the authority of the Chief Judge and before the start of the first event, that is, before the first skier taking part in the first event has started.
- 3) The substitute skier shall start first in the series in which he is qualified unless the draw has not yet been completed.

#### b) Team or individual athletes not showing up:

In the event a team or individual athletes (for whom their Federation has submitted a competition entry), fail to show up for a competition, their entry fee shall still be payable in full, unless a valid written excuse is received by 12 noon of two days before the start of the competition.

A valid excuse may include a sickness certificate or a certificated injury and should be considered and agreed as valid by the IWWF Representative at the Championships.

All fines have to be paid on-site to the IWWF Representative at the Championships. No skiers will be allowed to start if any due fine is not paid.

If the "valid excuse" is accepted, the money will be refunded by the Organiser to the relative Federation, within 30 days after the end of the competition.

#### **EMS SKIERS' REGISTRATION PROCEDURE**

The registration of the participation in EMS has to be done by an EMS Federation Administrator as follows:

- 1. EMS Federation Administrator has to login to EMS.
- 2. Go to the Competitions menu and enter the Competition Code **25IWWF01** in the search filters and erase the Country filter.
- Select the competition listed "2025 IWWF World U21 Waterski Championships".
- 4. Select the Participations tab and click the "New participation" button to register the Athletes.
- 5. Enter the Name of the Athlete in the Search box and click on the loop sign to the right.
- 6. Register the Category in Competition, the Events "and the Entry Type.
- 7. Click on the blue "Add" button and the participant will be registered.
- 8. Click the Competition Entry Fee Product item and the "Save" button.
- 9. A message "Participation added successfully" appears. Click "X" on top right of the window.
- 10. If you need to register additional participants click "No" on the question "Do you want to pay now?" and repeat steps 5 to 10 for additional participants.
- 11. If you want to proceed to payment click "Yes".
- 12. Select the participants for whom you want to pay and click the Total Amount button on the bottom to the right.
- 13. Click the button "I agree to the Terms and Conditions" and click on the payment method button:
  - "PayPal": Login to your PayPal account and select your payment method (from your account or a credit card). Click the "Complete Purchase" button.
  - "Debit or Credit Card" button: Enter the card details and click the "Pay" button on the bottom.
  - If the payment is successful a message "Payment Success" will appear.

#### **Entry Fee**


The Entry Fee for the 2025 IWWF Under-21 World Waterski Championships is **US\$ 330,00 per competitor** regardless of discipline.

#### **Entry Fee payments**

Payments of the Entry Fees must be made at the time of athlete registration on the EMS website.

Remitting parties are responsible for ALL bank charges at both ends. Where bank charges have been deducted, Federations/Skiers will be required to make good any shortfall at registration. #### OFFICIAL FAMILIARISATION (IWWF WATERSKI RULE 14:07) 6.

#### 14.07: Site Familiarisation

The last two or three days immediately before the Championships will be reserved and used for Official Familiarisation. This will be organised so that each competitor who has paid shall be allocated either a set number of passes and/or a certain amount of time at the discretion of the Chief Judge based on the principle that every skier shall receive an equal opportunity for familiarisation.

Slalom skiers will receive 4 passes or 6 minutes whichever is less Tricks skiers will receive 2 passes or 5 minutes whichever is less *Jump skiers will receive* 3 passes or 6 minutes whichever is less

60 days before the Championships each entered competitor will be allocated Official Familiarisation time as specified above. 45 days before the scheduled start of the event, the Organiser (in consultation with the Chief Judge, whose decision shall be final) shall announce the official familiarisation schedule (including the allowed time).

If a Federation does not want to take part in the Official Familiarisation, it must notify the Organisers and the Chief Judge as soon as possible.

The order for familiarization will be based on the team results from the previous WWF World Championships with the last placed team athletes going first, and shall be grouped by event, i.e., slalom familiarization, trick familiarization and jump familiarization (by jump height) will be grouped together. Any athlete whose time has not been paid for at least 30 days before the scheduled start of the event, or who is not ready to ski in accordance with the schedule, will lose their official familiarization time.

## **Summary Table**

June 16<sup>th</sup> 45 days before deadline for publishing familiarisation schedule by Organiser.


July 1st 30 days before deadline for familiarisation payment.

The Chief Judge shall have the discretion to change the start time of team's familiarisation based on extraordinary circumstances.

During the Official Familiarisation period the Chief Judge may allocate any available site familiarisation times but only to skiers who have not already used it or do not have time allocated.

#### Official familiarisation cost is: USD5.00 per minute.

## 7. TRAINING

It will be possible to train at the official venue from June 1, 2025, to July 27, 2025, at a cost of **US\$ 300.00 per hour in 10-minute increments** (single sets = 9m30s) behind a Ski Nautique.

Each federation MUST identify one key contact/liaison for booking all unofficial training using this <u>link</u>. To book please complete your participation survey and name your contact person in the survey. Once you have completed the survey, and confirmed unofficial training times you will be emailed a payment link.

Dates and times for the training must be requested to the email <u>U21worldstraining@gmail.com</u>. 50% of the cost is due upon confirmation from the organizer, 50% is due June 1. All bank charges are the responsibility of the paying party.




## 15. LOCAL CURRENCY
